TOPIC	Property on Abandoned Road Evans
PRESENTED BY	Mike McArtor
DISCUSSION	Shane Tilton and his wife Brandy Hughes own a parcel on the abandoned Evans Road. Evans Road has been abandoned from maintenance for hundreds of years without a date on record of when it was abandoned. Mike explained that we have talked with many of the county and state officials including the Licking County Prosecutors office and the office of Kevin Miller regarding abandoned roads. The trustees have yet to receive an answer on rights of the property owner along with what party is responsible to pay for the opening of an abandoned road. For Perry Township trustees to remove abandoned status, someone has to pay to reopen the road and then pay to maintain it.

Shane Tilton stated they are exploring options on how to get
access to their property. Some of those options include asking
adjacent property owners to purchase a piece of their property in
order to gain access to Evans Road. As well as, going to ODOT to
see if there is an economical way for the state to help the township
open up the road.

county commissioners.
